Quantitative Angaben nach EU-Taxonomie

Die dwpbank legt derzeit die Green Asset Ratio als relevante Kennzahl im Sinne der EU-Taxonomie offen. Die Green Asset Ratio errechnet sich bei Kreditinstituten aus dem für sie typischerweise überwiegenden Zinsgeschäft.

In der Berichterstattung über das Geschäftsjahr 2026 wird die „Green Fee“ als Kennzahl ergänzt. Sie wird die EU-taxonomiekonformen Provisionserträge ausweisen. Aufgrund des sehr eingeschränkten Kreditgeschäfts der dwpbank weist sie nur geringe absolute Werte bei der Green Asset Ratio aus.

Die EU-Taxonomie unterscheidet zwischen taxonomiekonformen Investitionsausgaben (CapEx) und taxonomiekonformen Umsätzen (Turnover), die jeweils nacheinander in den einzelnen Unterkapiteln dargestellt werden.
